**Basic RiderCourse (BRC) FEE: \$250.00**

The Basic RiderCourse curriculum runs approximately 15-18 hours. Classes go on rain or shine. RENJ provides the motorcycle and helmet (if needed) and insurance. You must provide full-fingered gloves, eye protection, over the ankle boots, a long sleeve jacket or shirt, and of course long pants. You may bring your own helmet provided it is DOT approved. Lunch and snacks are required, there is water on site. **You must have a validated motorcycle permit with you throughout the entire class. If you do not have a validated permit you will not be allowed to attend the class, and will forfeit the fees paid.** A validated permit includes a passed written and vision test. Both must be indicated in writing on the front of the permit. The permit must be stamped to show you are approved for practice riding. Check your expiration date; your permit expires every 90 days, and you must retake the written and vision test every 2 years. The permit must be valid through the entire course as successful completion of the BRC course waives the NJ MVC road test, providing you also have a valid NJ auto license at the time of the course. RENJ has been approved by the Motor Vehicle Commission to offer the NJ Motorcycle Safety Education Courses. RENJ does not assume any responsibility for errors made by Motor Vehicle Services. You must ensure that your paperwork is correct.

Because riding any two wheel vehicle involves balance YOU MUST currently and proficiently ride a bicycle. You will be tested on a bicycle prior to being allowed to ride a motorcycle in the class. Not being able to handle a bicycle in a safe manner will excuse you from further participation in the class and no refund will be given.

**Experienced RiderCourse (ERC) (Circle one) FEE: ERC \$100 / 2-UP ERC \$120.00**

This course is primarily for the rider who has ridden a minimum of 6 months or 3000 miles. The ERC is an 8 hour program that is taught using your own motorcycle. Your motorcycle must be registered, inspected and insured. You must have a current motorcycle license. Make sure you have all the paperwork with you. The course consists of combined classroom and on-cycle instruction, and a lunch break. Bring your own safety gear which includes full fingered gloves, a long sleeved shirt, over the ankle boots, long pants, approved eye protection and a DOT approved helmet. Applicants must be over 18 years of age. **Classes go on rain or shine.** The ERC is also a state approved Defensive Driving Course that enables you to get a 2-point reduction off your license once every five years provided you pass the ERC written test.

**If you must cancel your scheduled class it is your responsibility to notify the RENJ office at least 10 business days before the class. Refunds are given minus a \$50 administrative fee or you can reschedule into another class, providing that one is available. If you need to make changes to a scheduled class there is a \$25 rescheduling fee. RENJ cannot carry funds over season to season; if you are eligible to reschedule, but there are no dates available, you will have to cancel with the applicable fee. No refunds will be issued and no rescheduling will occur if you cancel less than 10 business days prior to the start of your scheduled class. You must be prepared and attend 100% of the class; you cannot be late, unprepared or miss any part of the classroom or range activities. If you do, you will lose your spot and your money.**

**It is the primary responsibility of the RiderCoaches to ensure that the class is held in a safe manner. Should you be excused by your RiderCoach for any reason, including but not limited to, an unsafe act while in control of a motorcycle, no refund will be given.
